#### What is the Restoration Advisory Board?

The Restoration Advisory Board (RAB) is comprised of members from Brevard County working in conjunction with Space Force personnel and the Florida Department of Environmental Protection (FDEP) concerning environmental cleanup activities at Patrick Space Force Base (PSFB) and Cape Canaveral Space Force Station (CCSFS).

The intent of the RAB is to bring together community members reflecting the diverse interest within the local community, enabling the early and continued two-way flow of information, concerns, values, and needs between affected communities and the SLD 45.

Currently, members of the RAB meet 3 times per year (February, June, October) to receive updates on program status and to discuss the technical approach to ongoing environmental studies and restoration activities at both PSFB and CCSFS. All RAB meetings are open to the public and technicians are available to provide support and additional restoration project and site information to RAB members.

#### **Member Responsibilities**

RAB members volunteer to serve a specified term and attend all RAB meetings. Members are expected to be available to community members and civic groups to facilitate the exchange of information and/or concerns between the community and the RAB. Members are welcome to provide feedback on technical documents and activities associated with the Installation Restoration Program at PSFB and CCSFS.
