

WARNING

RNA/Security Zone

Any person or vessel requesting to enter, pass through or remain in the RNA shall request authorization from the Captain of the Port under the authority of 33 CFR 160.111 and Title 46, United States Code (USC), Parts 70002 and 70036. No person or vessel may enter the Security Zone. Failure to comply is punishable by a fine of not more than \$250,000 or imprisonment for not more than six years, or both.

<u>Surveillance Area</u>

Extremely hazardous conditions will be present within the surveillance areas. Mariners are strongly advised to avoid these areas while active.
