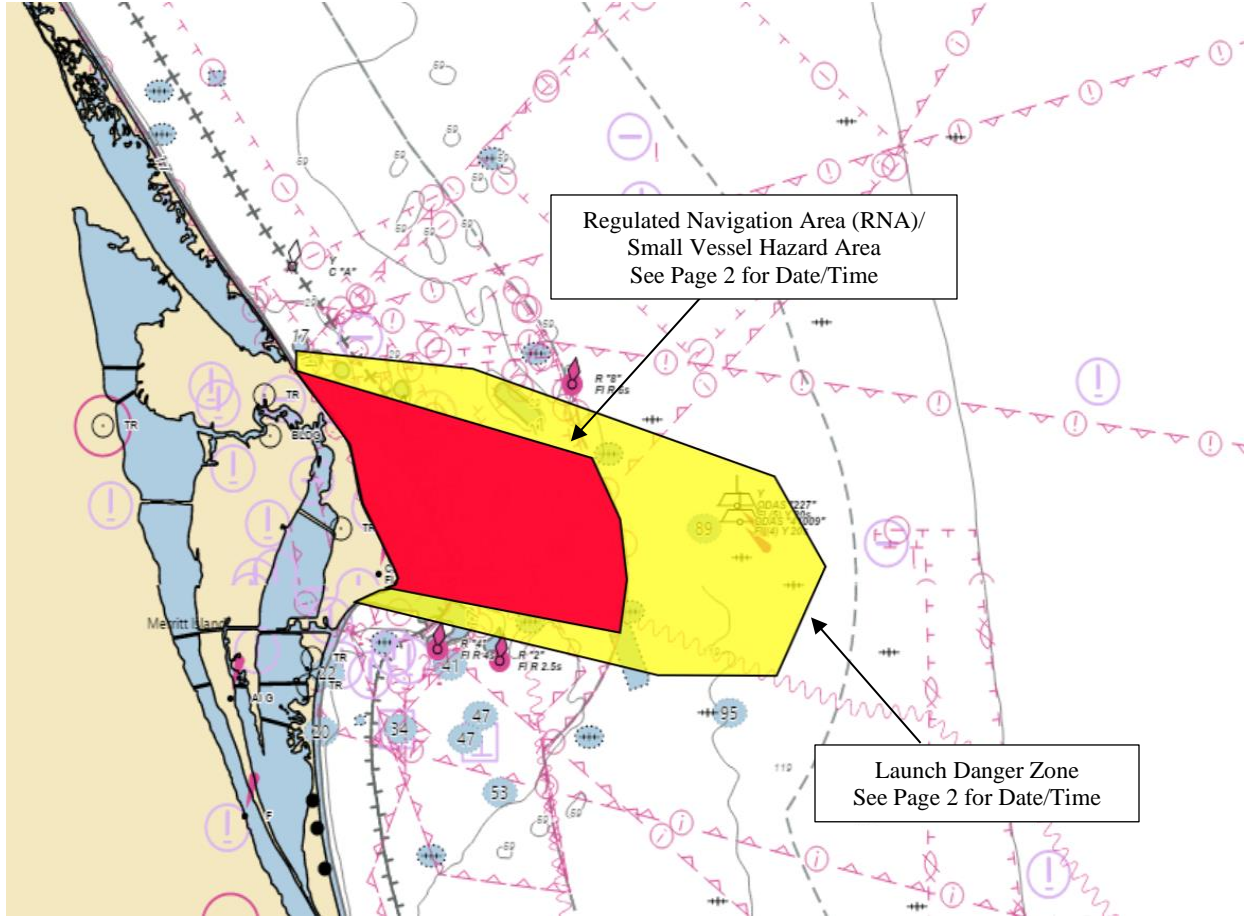

WARNING

RNA/Security Zone

Any person or vessel requesting to enter, pass through or remain in the RNA shall request authorization from the Captain of the Port under the authority of 33 CFR 160.111 and Title 46, United States Code (USC), Parts 70002 and 70036. No person or vessel may enter the Security Zone without authorization from the Captain of the Port. Failure to comply is punishable by a fine of not more than \$250,000 or imprisonment for not more than six years, or both.

Launch Danger Zone

It is strongly recommended that mariners avoid this area while the RNA is in effect. This area depicts where hazardous conditions may be present in the event of a vehicle malfunction. These hazards may include free falling debris and descending vehicles or vehicle components under various means of control, which could cause injury, death, and damage to vessels.
